Text:

Federal Taxation of Business Organization and their Owners by Lorence Bravenec and S.R. Singer. CCH 2013 edition. Order from CCH or from Amazon. One book per group is sufficient.

Course Objectives:

The primary objective of this course is to introduce students to issues in contemporary tax practice including discussion of landmark judicial decisions, tax administration and practice, tax planning and compliance for individuals and businesses, choice of business form etc. Students will work with real-life cases dealing with complex tax issues.

Assessment:

Assessment will be made using quizzes, homework, exams and tax preparation projects. While class participation and attendance are not explicitly graded, it is important to be present and actively engaged in class in order to do well in this course. This is an intensive course and will require significant out of class study time.

Homework and Projects

Homework and projects will be periodically handed out in class. They are due on the date indicated. No late work will be accepted. It is the responsibility of the student to be present in class and keep himself/herself informed regarding homework, assignments and due dates.

Exams:

There will be three exams including a final in this course. Final grade will be based on two best efforts:

Tentative letter grades are as follows: 90% and above A; 80% and above B; 70% and above C; 60% and above D, below 60% F. Depending upon the final grade distribution, I may look for natural separation and may assign the grades based on a Gaussian distribution. Regardless, meeting the above thresholds will guarantee the stated minimum grade.
