COURSE DESCRIPTION: Study of the use of accounting information for business decision making.

<u>COURSE OBJECTIVES</u>: Course emphasis is on the identification and assignment of product cost, operational planning, cost control, and management decision making.

EXAMS: The course will have five regular exams and a comprehensive final exam. Each regular exam will consist of 25 multiple choice questions and the comprehensive final exam will consist of 50 multiple choice questions. The lowest exam score will **not** be dropped.

Please note the following:

- a. You will need to submit a **print out of your grade calculation to sit for each exam** using the sample spreadsheet posted on blackboard.
- b. All exams will be taken online in the Testing Center, room 301, Sage Hall, using UNT desktop computers. You may use a calculator of your choice but no smart phone or tablet. The University will **not** be providing calculators for you.
- c. I reserve the right to seat and/or re-seat any student before or during an exam.
- d. Due to Federal HIPPA regulations, I am not allowed to discuss a student's exam **results** where other students can over-hear, over the phone, or through email. Please be cognizant of this requirement and limit such discussions to my office.

QUIZZES: There will be 11 Quizzes given during the semester with the top ten quiz grades being used to calculate your grade in the course. You are responsible for monitoring the due dates and times listed in MAL.

HOMEWORK: There will be 11 Homework assigned during the semester with the top ten homework grades being used to calculate your grade in the course. You are responsible for monitoring the due dates and times listed in MAL.

MAL will allow you to continue to attempt to complete each problem until you are able to get it right for a maximum of 5 attempts; or until the window for that chapter's assignment closes. Partial credit is given for partially completed homework problems so use the 80/20 rule wisely.

PEARSON MY ACCOUNTING LAB: All homework, quizzes, and exams; except for the comprehensive final will be in MAL with due dates indicated in multiple areas of MAL. MAL has a variety of additional aids to help you master the material. Students have singled out the Study Plan as being particularly helpful for identifying weak areas that need additional attention.

Please note:

- a) MAL is **not** integrated with the UNT Blackboard system for this course
- b) No grades will be posted on Blackboard except the grade for the comprehensive final exam at the end of the semester

<u>CLASS ATTENDANCE</u>: We will take roll at the beginning of each class. Class attendance is strongly encouraged and has been shown to be a factor in success in the course. However, attendance will **not** be graded.

CLASS PREPARATION: Read and study the chapter before we go over it so that you will have an idea of calculations and concepts that need clarification.

<u>CLASS DISCUSSION PROBLEMS:</u> We will go over the class discussion exercises listed in the Class Schedule posted in Blackboard. These exercises will contribute to building your knowledge and skill set so you will be successful on the homework, quizzes, exams, and, **most importantly, life**.

DROPPING THE CLASS: University policy relative to dropping the class will be followed. **February 26, 2016,** is the last date you can drop with an automatic grade of W. After this date through **April 5, 2016,** you must have the instructor's approval in order to drop the course with a grade of W. You should consult with your academic advisor prior to the above dates if you are considering dropping this course. Please note that a student can be dropped by the instructor with a grade of WF if they do not attend class and take exams.

COMMUNICATING WITH THE INSTRUCTOR: When I interact with you, I want to be responsive. However, I have 160 students in four different 2020 classes. If you will adopt the following suggestions, I will have a better chance of helping you in an effective and timely manner.

a. Email is the preferred manner of communication. If you email me, do not assume that I received your email unless I confirm receipt and ALWAYS include your section number and full name. This protocol should be followed even if I am familiar with you as a student and know your name.

- b. When leaving me a phone message, please speak clearly and slowly and make certain to leave me a number and time when I can return the phone call. You should follow all phone calls up with an email communication as well.
- c. When you do come see me in my office, it will be helpful for you to remind me of your name and the section number you are in.

MYUNT & BLACKBOARD: I will use UNT's MYUNT and Blackboard systems extensively during the semester to communicate with the class. Changes to this Syllabus or other class structure or schedules will be communicated in class and through these systems. You are responsible for monitoring your MYUNT and Blackboard accounts and the associated email addresses connected to them. If you have had no previous experience with the system, you should take advantage of the available training resources at the very beginning of the semester.
