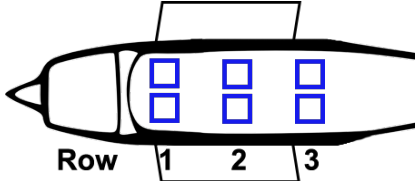
IN CONSIDERATION FOR BEING PERMITTED TO PARTICIPATE IN AN AVIATION ACTIVITY, I, ON BEHALF OF MYSELF AND/OR A MINOR CHILD UNDER MY GUARDIANSHIP, VOLUNTARILY CHOOSE TO PARTICIPATE WITH FULL KNOWLEDGE OF THE INHERENT RISKS AND HAZARDS, INCLUDING POSSIBLE INJURY OR DEATH, AND DO HEREBY EXPRESSLY ASSUME ALL SUCH RISKS AND VOLUNTARILY AND KNOWINGLY COVENANT NOT TO SUE AND TO RELEASE AND DISCHARGE THRUST FLIGHT, ITS AFFILIATES, OFFICERS, DIRECTORS, EMPLOYEES, CONTRACTORS, SHAREHOLDERS AND THEIR RESPECTIVE HEIRS, EXECUTORS, ADMINISTRATORS, LEGAL REPRESENTATIVES, INSURERS AND ASSIGNEES ("RELEASEES") FROM ANY AND ALL CLAIMS, DEMANDS, ACTIONS OR RIGHT OF ACTION THAT THE UNDERSIGNED NOW HAS OR MAY HAVE IN THE FUTURE, KNOWN OR UNKNOWN, OF WHATSOEVER KIND OR NATURE, IN LAW OR EQUITY, OR THAT OF ANY PERSON CLAIMING THROUGH ME OR ON MY BEHALF MAY HAVE OR CLAIM TO HAVE, WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE, CREATED BY OR ARISING OUT OF OR AS A RESULT OF PARTICIPATION IN AN AVIATION ACTIVITY. IT IS MY INTENTION THAT THIS RELEASE BE BINDING UPON MYSELF, MY HEIRS, LEGAL REPRESENTATIVES, EXECUTORS, ADMINISTRATORS AND ASSIGNEES.

The undersigned agree to indemnify the Releasees for any loss, liability, damage or cost Releasees may incur due to the undersigned's participation in aviation related activities, whether caused by the negligence of Releasees or otherwise.

I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad as permitted by the State of Texas and that if any portion of this agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This release contains the entire agreement between the Participant and Releasees and the terms of this agreement are contractual and not a mere recital.

HAVING READ AND UNDERSTOOD THIS AGREEMENT AND HAVING FULLY INFORMED MYSELF AS TO THE MATTERS THEREIN, I AGREE TO ALL TERMS AND CONDITIONS AS SET FORTH HEREIN IN EXCHANGE FOR BEING ALLOWED TO PARTICIPATE IN AVIATION ACTIVITIES. I UNDERSTAND THIS IS A BINDING CONTRACT.
