### Tiered Progression

All students admitted to the Ryan College of Business (RCOB) enter under the RCOB Tiered Progression Program. This program is designed to encourage advancement at an acceptable pace to timely graduation.

#### Tier One—Pre-Business (PBUS)\*

All new freshmen, transfer and continuing students who have less than the required grades in designated courses (listed below) will enter RCOB as PBUS. PBUS students must obtain academic advisement each semester in BLB 110 in order to receive their advising code for access to the registration system.

To progress to Tier Two (BUND), students must:

- complete at least three of the following pre-business (or equivalent) courses with minimum grades of two B's and one C:
  - College level Math, ACCT 2010, ACCT 2020, ECON 1100, ECON 1110, DSCI 2710
- have a 2.0 minimum UNT cumulative GPA (or transfer GPA if first semester transfer student).

#### Tier Two—Business Undergraduate (BUND)\*

Students who have met the progression requirements listed in Tier One will be admitted to RCOB as BUND. In order to progress and be accepted into Tier Three (Declared Business major), students must:

- have a 2.0 minimum UNT cumulative GPA (or transfer GPA if first semester transfer student)
- complete (with a grade of C or higher) all nine of the pre-business courses (courses in gray areas on opposite page) with a minimum GPA of 2.7

**\*Important Note:** All PBUS and BUND students are restricted to 1000/2000 level business courses. Enrollment in 3000/4000 level business courses are permitted upon successful completion of all pre-business requirements.

#### Tier Three—Officially a Declared Business major

Students who have successfully completed:

- All nine pre-business courses in the gray shaded area on the opposite page with a C or higher
- Have a 2.0 UNT GPA
- Have a 2.7 pre-business GPA

Will need to meet with an academic advisor in BLB 110 to request an official degree plan and acceptance into one of the professional field/majors offered by the Ryan College of Business.

\*Business foundation courses. These must be completed with a grade of C or higher prior to enrolling in BUSI 4940.

\*\* Courses that will fulfill university core and pre-business requirements. Courses used to fulfill both University and College requirements will increase number of required free electives to reach the 120 hours minimum for graduation. Consult with your advisor for questions on number of free electives needed.

- This schedule is only a suggestion; make sure you understand the necessary prerequisites for each course and consult the Undergraduate Academic Advising and Student Services Office. Course availability subject to change; actual degree audits may change depending on course availability in a given semester.
- **Before enrolling** in MATH 1190, the correct math placement is required or you must pass the prerequisite math with a grade of C or higher.
- **Bolded courses** above are pre-business courses that must be completed prior to enrolling into JR/SR level business courses. These courses must be completed with a grade of C or higher, as well as a 2.7 pre-business GPA and a minimum 2.0 UNT GPA. Students must also complete 45 hours before enrolling in JR/SR level courses and/or filing for an official degree plan.
- A total of 120 credit hours are required for this degree. GPA requirements for graduation: 2.0 UNT cumulative, Professional Field varies by major (see advisor), and 2.0 Overall.
