

### University Core (42 hours; hours may vary - see below)

In order to reach 120 hours, this degree will require students to take some courses that are used to fulfill two requirements between the core and the pre-business. **IMPORTANT NOTICE:** In order to enroll in JR/SR level courses and file a degree plan, students must: complete 45 hours, complete the pre-business requirement courses with minimum grades of C; have a minimum 2.7 pre-business GPA; AND have a minimum 2.0 UNT cumulative GPA.

**A total of 120 undergraduate credit hours and 33 graduate credit hours are required for this degree. GPA requirements for admittance to the graduate (MS) portion: must have a 3.0 overall GPA, and a 3.0 on specified list above under Professional Field.**

**A grade of "C" or higher is required in all Pre-Business, Professional Development, Business Foundation, Professional Field, and Supporting Field courses.**
